विषय: उच्चतर शिक्षा संस्थानों में प्रवेश और केंद्रीय/राज्य सरकार के अधीन रोजगार के प्रयोजनार्थ कक्षा 10 और 12 की बोर्ड परीक्षा अर्हताओं के संबंध में भारत के स्कूल शिक्षा बोर्डों द्वारा मंचालित अर्हता/पाठ्यक्रम/परीक्षा की ममतुल्यता—के संबंध में।

सं. एफ. 11-3/2016-स्कूल. 3—सरकार के यह संज्ञान में आया है कि उच्चतर शिक्षा संस्थानों में प्रवेश और केंद्रीय/राज्य सरकार में रोजगार के संबंध में भारत के स्कूल शिक्षा बोर्डों द्वारा जारी प्रमाणपत्रों की ममतुल्यता के संबंध में द्वात्रों को कठिनाइयों का सामना करना पड़ रहा है।

2. उपरोक्त सुदूरे के समाधान के लिए, उच्चतर शिक्षा विभाग, शिक्षा मंत्रालय के परामर्श से स्कूल शिक्षा और साक्षरता विभाग, एतद द्वारा उच्चतर शिक्षा संस्थानों में प्रवेश और भारत की केंद्रीय/राज्य सरकार के अधीन गोजगार के प्रयोजनार्थ, कक्षा 10 और 12 बोर्ड परीक्षा अर्हता (जैसा लागू हो), के संबंध में भारत के माध्यमिक/विद्युतीय परीक्षा बोर्डों द्वारा अपने द्वात्रों को प्रदान किए गए माध्यमिक/विरिट भाग्यमिक प्रमाण पत्र को ममतुल्यता प्रदान करने की जिम्मेदारी भारतीय विद्यविद्यालय भंग (एआईयू) गो सीमित है। यह प्रावधान मंसद या राज्य विधानसभा के अधिनियम, या केंद्रीय/राज्य सरकार के कार्यकारी आदेश द्वारा स्थापित अथवा केंद्रीय/राज्य सरकार के निकायों/संस्थानों द्वारा (जिन्हें ऐसा करना अधिवेशित है) स्थापित भरकारी और निर्मी दोनों भारतीय स्कूल बोर्डों पर, निम्नसिखित शर्तों के अध्यर्थीन लागू होगा:

- क. इस कार्य को करने के लिए एआईयू प्रपनी क्षमता में समुचित रूप से बढ़ि करेगा।
- ख. इस कार्य को करने के लिए एआईयू शिक्षा मंत्रालय से किसी प्रकार के कंड/जनुदान की मांग नहीं करेगा।
- ग. इस प्रयोजनार्थ स्कूल शिक्षा और साक्षरता विभाग और उच्चतर शिक्षा विभाग, शिक्षा मंत्रालय के परामर्श से भारत के सभी स्कूल बोर्डों के लिए एक मानक संचालन प्रतिक्रिया (एसओपी) तैयार की जाएगी।
- घ. एसओपी में अन्य बातों के साथ-साथ यह मुनिश्वित विद्या जाएगा कि आवेदक स्कूल शिक्षा बोर्ड शिक्षा का अधिकार (आरटीई) अधिनियम, मौजूदा ग्राहीय पाठ्यचर्चा कार्यदाता (एनसीएफ) का अनुसरण और ग्राहीय शिक्षा नीति (एनईपी-2020) का अनुपालन कर रहा है और यह कि बोर्ड से संबद्ध स्कूलों के शिक्षकों के पास ग्राहीय शिक्षक शिक्षा परिपद (एनसीटीई) द्वारा निर्धारित अहंताएँ हैं।
- ड. ऐसी ममतुल्यता प्रदान करने समय एसओपी यह भी सुनिश्चित करेगा कि सम्पर्क समुचित प्रतिक्रिया महत्व हो और मौजूदा एनसीएफ पर आधारित हो, परीक्षाओं और संचालन की स्पष्ट योजना/उप-नियम हों और स्कूल बोर्डों पर जागू अन्य सभी मौजूदा कानूनों/नियमों/विनियमों/प्रक्रियाओं का पालन करती हो।
- च. एक बारगी उपाय के रूप में, एआईयू एसओपी जिसकी कार्यविधान से पूर्व उच्चतर शिक्षा विभाग और स्कूल शिक्षा और साक्षरता विभाग, शिक्षा मंत्रालय द्वारा जांच की जाएगी, का मसौदा तैयार करने के लिए यूजीसी, एआईसीटीई, एनसीईआरटी, मीटीएमई, एनआईओएम तथा अन्य सदस्यों जैसा एआईयू उपर्युक्त समझे, सदस्यों वाली एक विशेषज्ञ समिति का गठन करेगा।
- 3. एआईयू द्वारा प्रदान की गई समतुल्यता बोर्ड समुचित के रूप में एवं स्वतः इसे एवं स्वतः इसे में भारत के बोर्डों के परस्पर समानता के रूप में देखा जाएगा। एआईयू द्वारा स्कूली शिक्षा बोर्डों को प्रदान की गई ममतुल्यता उच्चतर शिक्षा और रोजगार के प्रयोजनार्थ अखिल भारतीय स्तर पर मान्य होगी।
- 4. इसे सक्षम प्राधिकारी के अनुमोदन से जारी किया जाता है।

**Subject:** Equivalence of Qualification/Course/Examination conducted by School Education Boards of India to grade 10 and 12 Board examination qualifications, for the purpose of admission in higher education institutions and employment under Central/State Government---reg.

No. F.11-3/2016-Sch.3—It has come to the notice of Government that difficulties are being faced by students in respect of equivalence of certificates issued by School Education Boards in India for the purposes of admissions in higher education institutions and employment in Central/State Government.

2. To address the above issue, Department of School Education & Literacy in consultation with Department of Higher Education, Ministry of Education, hereby entrusts the responsibility of granting equivalence to Secondary/Senior Secondary certificate awarded by Secondary/Senior Secondary School Examination Boards in India, with grade 10 and 12 Board examination qualifications (as maybe applicable), for the purpose of admission of its students to higher education institutions and for the purpose of Central/State Government employment in India, to Association of Indian Universities (AIU). This provision will be applicable to both Government and private Indian School Boards, that are set up by an Act of Parliament or state legislature, or by an Executive order of the central/state government or set up by central/state government bodies/institutions that have the mandate to do so, subject to the following conditions:

- a. AIU will appropriately enhance its capacity to undertake this task.
- b. AIU shall not seek any funds / grants from the Ministry of Education for this task.
- c. A Standard Operating Procedure (SOP) will be prepared for this purpose for all school boards in India in consultation with Department of School Education & Literacy and Department of Higher Education, Ministry of Education.
- d. The SOP shall ensure inter alia that the applicant School Education Board is following the Right to Education (RTE) Act, extant National Curriculum Framework (NCF) and is National Education Policy (NEP-2020) compliant and

that the teachers in schools affiliated to the Board possess qualifications as laid down by National Council for Teacher Education (NCTE).

e. The SOP shall also ensure that the due diligence process is rigorous and is based on the extant NCF, a clear-cut scheme/bye-laws of examinations and affiliation and follows all other extant laws/rules/regulations/processes applicable to School Boards while granting such equivalence.

f. As one time measure, AIU shall constitute an expert committee comprising representatives from UGC, AICTE, NCERT, CBSE, NIOS and other members as deemed fit by AIU for drafting the SOP that shall be examined by the Department of School Education & Literacy and Department of Higher Education, Ministry of Education prior to implementation.

3. Equivalence granted by AIU will be automatically considered as inter-se parity between the Boards in India, permitting smooth Inter-School Education Board migrations. The equivalence given by AIU to a School Education Boards shall be valid at all India level for the purpose of higher education and employment.

4. This issues with the approval of Competent Authority.



Therefore, Education Departments of all the States / UTs are requested to furnish compiled list of School Boards in their States / UTs to this Ministry (from Government official Email ID) at email addresses vibhutin.shukla@gov.in and gksandilya.edu@nic.in latest by 20.02.2023.

**Subject: Equivalence of Grade 10 and 12 Board Examination/Qualification/Courses conducted by Bhartiya Shiksha Board, Haridwar with Examination/Qualification/Courses conducted by other Central/State School Boards of India for the purpose of admission in higher education institutions and employment in Central/State Government organizations/bodies.**

Sir,

This is with reference to your application dated 18<sup>th</sup> July, 2022 on the subject cited above, followed by presentation made by your representative before AIU Expert Committee on 27<sup>th</sup> July, 2022. The matter was placed before the Equivalence Committee and Governing Council of AIU for consideration.

2. I am pleased to convey that the Governing Council of Association of Indian Universities (AIU) in its meeting held on 2<sup>nd</sup> August, 2022 has approved the recommendations of Equivalence Committee of AIU and expert committee constituted for scrutinising the applications in accordance with approved Standard Operating Procedure (SOP) that Bhartiya Shiksha Board, Haridwar meets the norms of the Govt approved SOP and equivalence may be granted.

3. Accordingly, the equivalence is accorded for Grade 10 and 12 Board examination qualifications of Bhartiya Shiksha Board that shall function as a Regular School Board within India. The equivalence is not for Open/distance/online qualifications of the Board.

4. The equivalence is subject to the compliance of the various norms of the approved SOP and especially the following conditions:-

- The schools/institutions affiliated to the Board shall be governed by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (RTE Act) and the rules framed there under.
- The Board must follow the provisions of National Education Policy (NEP) 2020.
- The Board must follow the provisions of extant National Curriculum Framework (NCF) for School Education as amended from time to time.

- (d) The Teachers appointed in schools affiliated to the Board must possess qualifications as laid down by National Council for Teacher Education (NCTE) from time to time.
- (e) The Board shall adopt Learning Outcome Based Assessment to help school to track progress of learning.
- (f) The Board shall maintain and update its website providing all vital information regarding the Board on the website like office address, constitution of various bodies of the Board, examination byelaws/rules, affiliation/accreditation byelaws/rules, list of affiliated schools/ accreditation centres along with their UDISE code, income and expenditure statement etc.
- (g) The Board shall follow various guidelines of Central/State government applicable on the school boards and affiliating schools.
- (h) The Board shall adhere to and ensure various acts & rules applicable on the schools for safety of students and employees like school safety policy 2016, sexual harassment of women at workplace, protection of children from sexual offences act 2012 etc. or any other rule or act passed by appropriate government applicable on school boards/schools.
- (i) The Board shall not indulge in any of the commercial or unethical practices with regard to the prescription of curriculum, textbooks, reading materials, evaluation processes and other classroom practices.
- (j) The Board shall have Government Representatives in its various committees like Governing Board, Executive Council and sub committees.
- (k) The Board shall continue to comply with AIU SOP in letter & spirit.

5. AIU may carry out review of documents/visits to check the compliance of the Board with the SOP any time. The case related to non adherence to the SOP norms by the Bhartiya Shiksha Board or its affiliated schools or unlawful act by the Bhartiya Shiksha Board/ Non-payment of Annual fee shall be treated in accordance with para 1.6 of Section III of the approved SOP.

6. The Bhartiya Shiksha Board is required to submit the acceptance to the above-mentioned conditions & submit the requisite fee for equivalence.
